Parent Liability Waiver for Pick up from the Cibola County School Systems

**Note*: As stated in the Carrot Express (CTA) Transportation Program Policies and Procedures, all children age 17 and under must have a liability waiver signed by the parent/guardian before they will be permitted to ride the transit vehicle. Children under 10 will need to have an adult retrieve them from the bus to ensure they are dropped off with the correct guardian. The Bus Driver is NOT allowed to leave their bus to walk a child into their destination.*

POLICY:

Unescorted children will only be picked up and dropped off at locations designated by the parent/guardian that sets up the schedule and signs the waiver. NO deviations will be allowed at the request of the minor. There needs to be a working phone number for the parent/guardian of the minor to be reached at all times. By signing this agreement, I agree that my unaccompanied minor will follow the rules of the Carrot Express (CTA) otherwise they may be removed from service.

Children are required to follow all rules for the Carrot Express (CTA), you will receive a hand out on the policy. There will be no bullying or fighting allowed on the bus. If your child is caught bullying or creating physical harm they will be permanently removed from the Carrot Express (CTA) services.

Your child needs to be at the bus stop at the time that you have them scheduled for. If your child is not out at that time the driver will have to leave. The driver/dispatcher will **NOT** be able to call parents if their child is not at the bus stop. The driver will not be able to deviate from the original drop off location unless the parents make prior arrangements at least 1 hour in advance.

After-School Transport: We begin taking reservations for afterschool transport July 1 and are normally booked up by the time school starts. Staffing limitations prohibit us from serving every school. Reservations are made for the entire school year. These reservations can only be taken from those ineligible to utilize the public-school bus system. Please make sure your child is on time to his/her pick up. The bus is not allowed to wait for children to get to the stop, they need to be there on time. If your child is not at the scheduled time the bus will have to leave to get the next passenger. No child will be able to ride without a parental consent form. Parents are required to inform dispatch if their child is not going to be riding the bus, every time via text message or phone call to dispatch.
